

THE FAMILY AT MARYLEBONE.

The information given under this heading was acquired when searching for the bridging of the Lowestoft and Sunderland Families. Unfortunately, I (Albert) cannot, with any certainty, state that this family had any connection with either of those lines, but publication of my findings preserves this information which otherwise might be lost. Doubtless a number of readers will fault some of the statements made and may be able to give a truer account of the happenings. This can be only part of the full story and any additions will be most welcome.

THE FAMILY AT MARYLEBONE

n.b. It is quite possible that this family links in with "The London Butchers" branch, only time will tell. The common link is with Marylebone in London.

The earliest mentioned was

Ambrose (Farratt) (1720) ⁽⁴²⁹⁶⁾ who married Mary ? ⁽⁴²⁹⁷⁾ to produce:-

and the following were possibly of the same family:

The brackets are mine to indicate a probable birth date.

Will (Farratt) 1760 ⁽⁴³⁰⁰⁾ married a Mary ? ⁽⁴³⁰⁴⁾ to produce

Thomas (Ferratt) ⁽⁴³⁰⁵⁾ b 31st August 1782

Samuel Andrew (Farratt) 1760 ⁽⁴³⁰¹⁾ married Sarah **Wright** ⁽⁴³⁰⁶⁾ on the 16th April 1783.

John (Ferratt) 1765 ⁽⁴²⁸⁶⁾ married Mary **Barugh** ⁽⁴²⁸⁷⁾ on the 19th April 1790

Silas Ferrett 1768 ⁽⁴³⁰³⁾ married Jane ? ⁽⁴³⁰²⁾ to produce an :-

Eliza (Ferrett) ⁽⁴²⁰⁷⁾

The next entry is :-

Elizabeth (Fairhead) (1745) ⁽³²⁰⁴⁾ who married William **Clutterbuck** ⁽³²⁰³⁾ on the 4th July 1768, at St. Marylebone Parish Church, Marylebone, London. The witness at this marriage was Isaac Fairhead ⁽³⁵⁷¹⁾ probably her father.

Now there is a generation gap, which is concluded by bringing **John Fairhead (1785)** ⁽³²⁰⁵⁾ into the picture by his marriage to Elizabeth **Sandon** ⁽³²⁰⁶⁾ on the 10th July 1810, at St. Marylebone Parish Church, Marylebone, London.

The following family is recorded to **John Nicholas (Fairhead)** ⁽³¹³⁶⁾ (also recorded as John Nicholson) and Elizabeth ⁽³¹³⁷⁾ :-

There is a possibility that there two families involved here, (although except for the first child they were all baptised at St. Mary's, Marylebone in London), or that some of the children died and their names were used again for succeeding children, a not uncommon practice in those days. As there is very little information about the children they have been classed as one family. The information on these children is as follows :-

Johnson Clayton 1811 ⁽³¹³⁸⁾ married Sarah **Newman** ⁽³¹⁴⁸⁾ (b.8/2/1823) in 1847, in the Marylebone District, London. Johnson Clayton died in 1884, in the Strand District, London.

Charles James 1813 ⁽³¹³⁹⁾ No record.

Charles James 1814 ⁽³¹⁴⁰⁾ No record.

James Charles 1815 ⁽³¹⁴¹⁾ No record.

James Charles 1818 ⁽³¹⁴²⁾ died in 1889 in the Hendon District, London.

James Thomas 1820 ⁽³⁰⁸⁵⁾ No record.

John Thomas 1820 ⁽³¹⁴³⁾ married Susan **Butcher**.

Frederick Francis 1822 (3144) married ? (?) (6593) in 1883 in the Kensington District, London

Catherine Elizabeth 1824 (3145) No record.

Alfred John 1827 (3146) No record.

Richard Frederick 1834 (3147) No record.

There were two **Ferrett's** born about this time:-

William Robert (4314) bap 28th October 1821
At St. Mary, Marylebone
(the son of Robert Ferrett (4328) and Ann ? (4329))

And

Mary (4315) b 29th May 1823
(the daughter of Robert Ferrett (4316) & Sarah Rees (4317))

It is not known if these two are related, or connected to the family above.

There was an **Austin Fairhead** (4308) who was married ? (?) (4309) on 29th March, 1871.
